### 4. CU 2020-01 CONDITIONAL USE PERMIT (K. OWENS)

(TAB 2)

To consider a Conditional Use Permit Application (CU-2020-01) by the applicant, Villa Italia Restaurant, Inc., to allow consumption of alcohol at 2808 10<sup>th</sup> Street West, Palmetto, Florida. A conditional use is required for consumption of alcohol on-site within the CN (Neighborhood Commercial) zoning district.

Mrs. Hill explained that the conditional use request is for the approval of on-site consumption of beer and wine for the existing restaurant. In 2014 the City adopted an alcohol ordinance that mandates a conditional use permit for the consumption of on-site drinking within the CG zoning district if within 200 feet of a residentially zoned property. Mrs. Hill explained that historically there have been restaurants and previous approved alcohol licensing for the subject property, and no known issues have been reported.

Several members from the public filled out speaker cards, and stated that they were in favor of the request. No members of the public spoke on this item. The speaker cards have been saved for the record.

The applicant was present.

Motion: Mr. Price moved, Mrs. Tarman seconded, and the motion carried 4-0 to recommend to the City Commission approval of the proposed Conditional Use Permit (CU 2020-01).
