4. ORDINANCE 2023-12 (K. HILL)

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF PALMETTO, FLORIDA, AMENDING APPENDIX B (THE ZONING CODE) OF THE CODE OF ORDINANCES TO PROVIDE FOR APPEALS OF DETERMINATIONS BY THE DIRECTOR OF PUBLIC WORKS TO BE HEARD BY THE CITY COMMISSION AFTER RECOMMENDATION BY THE PLANNING AND ZONING BOARD; AMENDING THE REQUIREMENTS FOR RELATING TO THE GRANTING OF A VARIANCE; TO PROVIDE FOR THE GRANTING OF VARIANCES BY THE CITY COMMISSION AFTER RECOMMENDATION BY THE PLANNING AND ZONING BOARD; ADDING DEFINITION FOR DIRECTOR OF PUBLIC WORKS; PROVIDING FOR CODIFICATION; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Mrs. Hill explained the proposed changes, as outlined in the agenda memo that was provided to the Board.

The Planning and Zoning board previously asked Staff to inquire with the Commission for more information regarding the reasoning for the amendment. Staff provided an update to the Board stating that no other information was provided from Commission. Discussion ensued regarding the proposed amendment, it was opined that the proposed changes would require an applicant to have an additional hearing date, which would add more time to the process. Discussion further ensued regarding Section 11.8, (f) regarding appeal stays. The Board requested the City Attorney review and if (f) could be removed.
