#### 6. INVESTMENT REVIEW

Mr. Thinnes discussed the third quarter investment review. The Portfolio was valued at \$10,602,239. Equity is slightly over-weighted. On December 1<sup>st</sup> Principal will be calling the money for the investment. Mr. Thinnes would like to use this opportunity to rebalance the Portfolio. There will be a couple hundred thousand dollars taken out of the Sawgrass Large Growth Equity allocation to fund the real estate investment. 10. FPPTA WINTER TRUSTEES SCHOOL FEBRUARY 1-5, 2015

Mr. Becks moved, Mr. LaRowe seconded, and the motion carried 4-0 to renew the membership to the FPPTA and authorize the expense of \$600.00 for the renewal.

FPPTA has not issued information for the Winter Trustees School. Staff asked who would like to attend and sought authorization to make arrangements for the Board. Mr. LaRowe and Mr. Becks will attend the winter school.

# 12. COUNTING AND CERTIFICATION OF BALLOTS FOR TRUSTEE ELECTION

Ballots were given to members of the Police Officers' Pension Plan for an election for Chair Stinson's seat. Per the Operating Rules and Procedures, the Board counted and certified the results which were as follows:

Mr. Gaulien moved, Mr. LaRowe seconded, and the motion carried 4-0 to certify that Mike Stinson won the November 2014 trustee election.

#### 13. NEW BUSINESS

Ms. Foley discussed Section 1.7 A of the Operating Rules and Procedures that states the ballots shall be counted by the Board and certified by the Board. She questioned if the Board would like to keep it this way or if they would prefer the ballots be counted ahead of time and a canvassing report prepared for certification at the meeting. The Board agreed that it would be more efficient to have the ballots counted by the City Clerk with a canvassing report to be certified by the Board at the meeting.

Ms. Foley reviewed Section 1.7 B of the Operating Rules and Procedures that states "two resident Trustees.....shall be appointed for two year terms in alternating years...." Currently Mr. Becks and Mr. Gaulien are the two resident Trustees whose terms both expire next year; not on alternating years as stated. Attorney Christiansen stated this can be fixed next year with either Mr. Becks or Mr. Gaulien's term being for one year instead of two; then each trustee will be on alternating years.

Motion:

Mr. Becks moved, Mr. LaRowe seconded, and the motion carried 4-0 to authorize Attorney Christiansen to update the Board's Operating Rules and Procedures with the correction to Section 1.7 A, ballots, and to update any other discrepancies throughout.

Chair Stinson adjourned the meeting at 9:35 a.m.
