14. DISCUSSION: WARD 1 COMMISSION SEAT VACANCY

Mayor Bryant presented two proposed options to the City Commission for filling the Ward 1 vacancy:

Option #1

- Establish timeframe for accepting resumes from interested residents and communicate process
 - 2-3 weeks ending October 14 or 21st
 - Issue press release stating criteria and process to submit
 - Post on website, local papers
- Have potential replacements complete an affidavit stating they meet eligibility requirements
- Potential candidate's resumes presented to Commission after the deadline
- Commission reviews the potential candidates based on resumes submitted
- Commission makes motion for a replacement at the November 7th meeting which could include one of the resumes submitted or anyone else who meets the qualifications

Option #2

- Commission can make a motion for a replacement at any time based on the resumes received to date or personal knowledge of someone who is interested and meets the qualifications
- Potential replacement to complete affidavit stating they meet eligibility requirements

MOTION: Commissioner Zirkelbach moved, Commissioner Cornwell seconded, and motion carried 4-0 to approve Option #1 with a three-week time period.

15. 23rd STREET REALIGNMENT UPDATE/BASEBALL FIELD UPDATE

Mayor Bryant provided Commission with a copy of a letter from County Administrator Ed Hunzeker in response to her letter regarding the ball fields. A copy of the letter is attached to these minutes. It appears the county is willing to do what the Little League had asked. The county can help with the land for the fields and the maintenance, which is what was agreed on initially; however, the county cannot

commit funds to help build the fields. Commissioners commented that the Little League just needs the fields at this point and could forego amenities for the time being.

The Commission reviewed the plans sent by the County.

Mayor Bryant said she will check with the School Board to see if the softball fields could be placed at the old Palmetto Elementary School site as part of the park complex. It will be some time before a new school goes there, and in the meantime the School Board has to maintain the property.

Mayor Bryant will discuss with County staff, and this item will be brought back to the next Commission meeting.

The Mayor brought up requests by charities to place inserts in the water bills, and Attorney Barnebey reiterated that this is not City policy. If you open up to one, you must open to all.
