## 7.CIP WATER AND SEWER LOAN RESOLUTION 2014-15

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PALMETTO, FLORIDA, ACCEPTING A PROPOSAL OF BRANCH BANKING AND TRUST COMPANY TO PROVIDE THE CITY WITH A LOAN IN ORDER TO FINANCE THE ACQUISITION, CONSTRUCTION AND INSTALLATION OF CERTAIN CAPITAL IMPROVEMENTS TO THE CITY'S WATER AND SEWER SYSTEM; APPROVING THE FORM OF AND AUTHORIZING THE EXECUTION AND DELIVERY OF A LOAN AGREEMENT; AUTHORIZING THE ISSUANCE OF A NOTE PURSUANT TO SUCH LOAN AGREEMENT IN THE AGGREGATE PRINCIPAL AMOUNT OF NOT TO EXCEED \$1,250,000 IN ORDER TO EVIDENCE SUCH LOAN; AUTHORIZING THE REPAYMENT OF SUCH NOTE FROM A COVENANT TO BUDGET AND APPROPRIATE LEGALLY AVAILABLE NON-AD VALOREM REVENUES; DELEGATING CERTAIN AUTHORITY TO THE MAYOR, CITY CLERK AND OTHER OFFICERS OF THE CITY FOR THE AUTHORIZATION, EXECUTION AND DELIVERY OF THE NOTE AND VARIOUS OTHER DOCUMENTS WITH RESPECT THERETO; DESIGNATING SUCH NOTE AS A QUALIFIED TAX-EXEMPT OBLIGATION WITHIN THE MEANING OF SECTION 265(B)(3) OF THE INTERNAL REVENUE CODE OF 1986, AS AMENDED; AND PROVIDING FOR AN EFFECTIVE DATE.

Ritesh Patel, Attorney with Nabors, Giblin & Nickerson, answered Commission's questions regarding the municipal loan agreement.

# Motion: Commissioner Cornwell moved, Commissioner Davis seconded, and the motion carried 4-0 to adopt Resolution 2014-15.

#### 8. RIVERSIDE BOAT RAMP UPDATE

#### 8A Riverside Boat Ramp RFP Committee Report

Bob Gause, Project Manager for the Riverside Boat Ramp Project, explained that the substantial completion date for this project will be February 2015 and it has been reported to the Southwest Florida Water Management District (SWFWMD) that the boat ramp will be completed by April 2015. There is room to add an extension to the agreement with SWFWMD; however, Mr. Gause prefers not to do that. The contractors that submitted their proposals for this project based their timeline on a start date after Labor Day. If this gets delayed, the substantial completion and final completion date will be pushed back further.

Mr. Burton agreed with Mr. Gause in regards to asking for an extension of the completion date with SWFWMD. He stated that there will be another application submitted to SWFWMD for grants for another project next year and he would like to remain in good standing with them in order to receive the funding.

#### Motion: Commissioner Davis moved, Commissioner Cornwell seconded and the motion carried 3-1 to accept the Riverside Boat Ramp Project ranking of 1. Halfacre Construction, 2. DeLesline Construction, and 3. Mathews Construction and authorize the Mayor to negotiate the contract with Halfacre Construction. Commissioner Varnadore voted no.

#### 9. ASR WELL UPDATE

Mr. Tusing stated the well is substantially complete. The ultra-violet testing should be underway mid-September to mid-October. Once the Department of Environmental Protection's requirements have been met, the water can start going down the well when available.
