### 9. COMMISSIONERS' COMMENTS

Chief Tyler informed the Commission that he recently drafted a letter that he would like to send to FDOT regarding the traffic accidents on 23<sup>rd</sup> Street and US 41. He proposes the median should be solid so that it does not allow a left turn lane from 23<sup>rd</sup> Street onto US 41.

<u>Commissioner Davis</u>—attended a ribbon cutting for the East Coast Migrant Head Start program. It was well attended and a nice facility.

He reminded everyone to go and vote tomorrow.

Mayor Bryant informed Commission that the Manatee County documentary "Through the Tunnel" [that discusses segregation in the 1960s and how Lincoln Memorial High School was involved] is being shown at this year's Sarasota Film Festival in April.
