AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF PALMETTO, FLORIDA, AMENDING CHAPTER 6, ARTICLE I, SECTION 6-1 OF THE PALMETTO CODE OF ORDINANCES, BIRD SANCTUARY, TO PROHIBIT THE HARBORING OR KEEPING OF CHICKENS EXCEPT IN CONFORMANCE WITH CITY REGULATIONS, AMENDING CHAPTER 6, ARTICLE II, SECTION 6-31 OF THE PALMETTO CITY CODE OF ORDINANCES, TO REGULATE CHICKEN-KEEPING WITHIN CITY LIMITS; PROVIDING DEFINITIONS; PROHIBITING ROOSTERS, FOWL, OR POULTRY OTHER THAN CHICKENS; PROVIDING GENERAL REQUIREMENTS FOR ENCLOSURES, LOCATION, AND MAINTENANCE; PROVIDING FOR EXCEPTIONS; PROVIDING FOR REPEAL OF ORDINANCES IN CONFLICT; PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

9. PUBLIC HEARING ORDINANCE 2018-05 904 11^{TH} AVE WEST VACATION AN ORDINANCE OF THE CITY OF PALMETTO, FLORIDA, VACATING A RIGHT-OFWAY APPOXIMATELY 114 FEET IN LENGTH AND 20 FEET WIDE, LYING EAST OF 11^{TH} AVENUE WEST, NORTH OF 9TH STREET WEST. SAID PARCEL IS LOCATED GENERALLY AT 904 11^{TH} AVENUE WEST, PID#2693600005, AND AS MORE PARTICULARLY DESCRIBED IN THIS ORDINANCE; PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

Mayor Bryant opened the public hearing.

Attorney Barnebey made the following change to Section 4 of the Ordinance which will now read as follows:

"This Ordinance shall take effect upon the later of the granting of a drainage, parking, and access easement, in a form acceptable to the City Attorney, to the City, over the western 10 feet of the area vacated; and execution by the Mayor or, if disapproval occurs, upon reconsideration by the City Commission and passage of the Ordinance by at least four votes."

Jeff Lawson, property owner, discussed why the vacation is necessary for the redevelopment of the property.

Garry Roberts, architect for the project, reiterated the need for the vacation of 10 feet with the western 10 feet being granted back to the City.

Brian Sellars, representing Leo Mills Surveying, stated that the survey has been completed and will be providing the Attorney with the survey regarding the western 10 foot piece of property that belongs to the City.

Mayor Bryant closed the public hearing after no further public comment.
