  Commissioner Cornwell expressed that the event's title that includes City may be mistaken as a City event and requested that it be noted that it is not a City event.

- 7. POLICE DEPARTMENT BUILDING GUARANTEED MAXIMUM PRICE (GMP) (M.RAYAN/S.TYLER/ J.FREEMAN)
  - Motion: Commissioner Williams moved, Commissioner Cornwell seconded, and the motion carried 5-0 to approve and accept the Guaranteed Maximum Price Addendum for Construction Management at Risk Services between the City of Palmetto and HJ High Construction for the construction of a new Police Department Building in the amount of \$10,341,705 dollars and authorize the Mayor to sign the Addendum and any associated documents.

POLICE DEPARTMENT BUILDING GUARANTEED MAXIMUM PRICE (GMP) DISCUSSION: The below public speakers provided comments on their approval of the new Police Department (PD) Building project.

Commissioner Smith expressed his concerns about the new PD Building project regarding the location and the City funding the project instead of the CRA. Mayor Bryant communicated that the Commission voted to not use CRA funds to build the new PD Building and asked how many times the PD project has been an agenda item at meetings. Mr. Freeman replied that it has been a standing item on the City Commission agendas at 7:00 p.m. since 2018.

# 8. <u>RESOLUTION 2021-33 POLICE DEPARTMENT BUILDING LOAN AND FUNDING PLAN (J.FREEMAN, M.BARNEBY)</u>

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PALMETTO, FLORIDA ACCEPTING A PROPOSAL OF STERLING NATIONAL BANK TO PROVIDE THE CITY WITH A TERM LOAN IN ORDER TO FINANCE CERTAIN COSTS OF THE CONSTRUCTION AND EQUIPPING OF A NEW POLICE DEPARTMENT BUILDING; APPROVING THE FORM OF A LOAN AGREEMENT; AUTHORIZING THE ISSUANCE OF A PROMISSORY NOTE PURSUANT TO SUCH LOAN AGREEMENT IN THE PRINCIPAL AMOUNT OF NOT TO EXCEED \$6,000,000 IN ORDER TO EVIDENCE SUCH LOAN; AUTHORIZING THE REPAYMENT OF SUCH NOTE FROM A COVENANT TO BUDGET AND APPROPRIATE LEGALLY AVAILABLE NON-AD VALOREM REVENUES; DELEGATING CERTAIN AUTHORITY TO THE MAYOR, CITY CLERK AND OTHER OFFICERS OF THE CITY FOR THE AUTHORIZATION, EXECUTION AND DELIVERY OF THE LOAN AGREEMENT AND THE NOTE AND VARIOUS OTHER DOCUMENTS WITH RESPECT THERETO; AND PROVIDING FOR AN EFFECTIVE DATE.

Commissioner Jones acknowledged that after reviewing the loan agreement, it is a great one. And, he expressed that he wants to make sure that the new PD Building will cost no more than the amount listed in the point paper (i.e., half cent sales tax, the general fund reserve, loan, etc.).

Motion: Commissioner Williams moved, Commissioner Cornwell seconded, and the motion carried 5-0 to adopt the Police Department funding plan as described and to adopt Resolution 2021-33 approving and authorizing the Mayor and Clerk to execute a Loan Agreement with Sterling National Bank and all related documents in connection with the issuance of the Special Obligation Revenue Note, Series 2021 in an amount not to exceed \$6,000,000.

Commissioner Smith requested clarification on the total funding plan for the new PD Building. Mr. Freeman referenced the point paper that summarizes the funding for the project that was included in the agenda packet and discussed all funding sources including the loan for the PD Building project.
