3. DOWNTOWN COMMERCIAL CORE REDEVELOPMENT INCENTIVES 2.0

There are currently three change orders for the Sutton Park Pavilion project that include lightning protection, amperage increases and Police Department signage.

The CRA is working with the Historic Park Board to fund security cameras, lighting, and garbage cans for the park.

He stated that the MLK Park is in the permitting stages with SWFWMD.

Mr. Burton discussed a meeting he will be attending on June 25th with SWFWMD regarding funding for the boat ramp.
