Bob Gause, Project Manager for the MLK Park and Riverside Boat Ramp project, stated that the ground breaking for the Boat Ramp will be held on September 22, 2014 at 5:45 p.m. He noted that as stated on the contract, substantial completion will be January 2, 2015 and final completion should be around February 2<sup>nd</sup>.

Mr. Gause stated that substantial completion for the first phase of MLK Park should be late October/early November 2014.

Discussion ensued between Commissioners and Mr. Gause regarding the second bridge that was to be built at MLK Park and the installment of bathrooms. Mr. Gause stated that the second bridge was eliminated, for now, because of some legal issues with the "Jackson" property next to the park. If and when all legal issues are settled with the adjoining property, the second bridge can be built at that time. Mr. Smith stated that the oil spill money that is to be awarded to the City is to be used for the construction of bathrooms. He would like a discussion on a future agenda regarding the second bridge and the construction of bathrooms because all other parks in the City have bathrooms for residents to use, except for Taylor Park. He stated restrooms are a priority for this park and a necessity for any park.
