## 1. CRA BOARD AGENDA APPROVAL

# Motion: Mr. Davis moved, Ms. Cornwell seconded, and the motion carried unanimously to approve the November 16, 2015 Special CRA Board Agenda.

## 2. PUBLIC COMMENT

Barbara Bush, president of Jet Mobile Home Park, addressed the CRA Board. She confirmed that she had been sworn. She said the park had heard rumors about a proposed kayak launch behind Jet Mobile Home Park and lighting all night along the canal. Mr. Burton explained the kayaks would be stored under the FPL solar installation. She was not familiar with the solar building, and Mayor Bryant said she would send the plans to her if she would leave her email address.

Mr. Burton explained the lights would be LED, and they are very directional; they aim down. He does not think any park lights are on all night long. They should not create a problem for Jet Park. There will be security cameras in the park, too.

Mrs. Bush said the park has privacy and security concerns with the kayak launch. Mayor Bryant informed her that the kayak launch is in the very initial planning stage.

Mrs. Varnadore asked the status of the community garden and if it needs to be part of the CRA Plan. Mr. Burton said it is in the CRA budget. He needs direction from the City on where to put it. Mrs. Varnadore asked if staff could make recommendations. She and Mr. Burton agreed to discuss the garden. Mayor Bryant commented she wants to be cautious and make sure it is sustainable.
