Mr. Smith stated that they have been trying to stop him from coming for 9 years. He disagreed with them denying him as a vendor.

Mr. Barnebey stated it is up to the CRA Board to decide how to move forward.

Mr. Williams said it was up to Mr. Johnson on how the situation would be handled. He noted that he oversees setting up vendors for the Manatee County Fair and has never had any issues with J&J BBQ.

Ms. Cornwell has done several events with J&J BBQ and in her experience, he was an excellent vendor as well.

Ms. Mathews questioned if he had other people that have worked for him at these events, as maybe the concern was with them and not him. He responded no, he has always been the one who participated at the 4th of July event.

Mayor Bryant noted that it will not be tolerated for anyone to come into the CRA office and yell at staff.

Mr. Johnson stated that he will be at this year's event and the rules will be followed. If they are not, the vendors will be notified in writing. He stated that they would give him another opportunity at this year's event.
