### SCOPE OF WORK: COMPLETE DEMOLITION

- Our proposal is based per site visit; drawings and specs not available. Our scope of work is listed below and is limited to these items.
- Remove from site (1) two-story, commercial structure including metal building structure, interior walls, office area, and loading ramp pit.
- Backfill for loading ramp pit is included; Forristall Enterprises, Inc. is to provide fill dirt for backfill.
- Building slab and foundation are to remain.
- No tree removal is included.
- Forristall Enterprises, Inc. will act with due diligence to protect the existing landscaping, but cannot guarantee that this will not be damaged during demolition. In the event that the landscaping is damaged in the process of demolition, Forristall Enterprises, Inc. will be held harmless.




