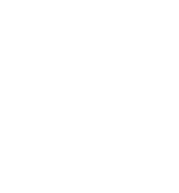





## RULES OF DECORUM

COMMISSION: While the Commission is in session, the members must preserve order and decorum, and a member shall neither, by conversation or otherwise, delay or interrupt the proceedings or the peace of the Commission nor disturb any member while speaking, or refuse to obey the orders of the presiding officer.

PERSONS ADDRESSING THE COMMISSION: Any person making personal, impertinent, slanderous or profane remarks, or who willingly utters loud, threatening or abusive language, or engages in any disorderly conduct which would impede, disrupt or disturb the orderly conduct of any meeting, hearing or other proceedings shall be called to order by the presiding officer and, if such conduct continues, may, at the discretion of the presiding officer, be ordered barred from further audience before the Commission during that meeting.

MEMBERS OF THE AUDIENCE: No person in the audience shall engage in disorderly conduct such as handclapping, yelling and similar demonstrations, which conduct disturbs the peace and good order of the meeting.

**EXCEPT FOR MEMBERS OF THE COMMISSION AND CITY STAFF, NO PERSON SHALL BE ALLOWED TO APPROACH THE COMMISSION DAIS WITHOUT THE CONSENT OF THE PRESIDING OFFICER.**
