**3. INTRODUCTION OF CRA ADVISORY BOARD MEMBER JOB DESCRIPTION**

This will be on a future agenda. **10<sup>th</sup> Avenue Roundabout** – Mr. Burton informed the advisory board that there is a potential availability of grant funds for roundabouts being considered for 10<sup>th</sup> Avenue and that preliminary conceptual and administrative work is being done. More details will be available later and this will be on the agenda for the meeting in January.
