Codes Violated: Palmetto Code of Ordinances, Chapter 7, Article XI, Section 7-242(a); Chapter 16, Health and Sanitation, Article II Nuisances, Section 16-26, Section 16-26 (2), (3) & (4) and Section 16-27(a), (b), & (c):

Code Enforcement Director Bill Strollo addressed the Board. He testified that he had been sworn and that his credentials are on file with the secretary of the Board. This property is a vacant house located at 401 17th Street West in Palmetto. Henry Lawrence is listed as the owner. The property is not in foreclosure. This property first came to the Board on October 31, 2006 as Case No. 06-14 with Debra Williams listed as the owner. Mr. Lawrence told the Board at that time that he would remediate the violations. He brought the property into compliance on November 28, 2006. Because the property was vacant and partially boarded over, Code Enforcement has continued to monitor it.

A Notice of Nuisance was issued on June 30, 2009. The City cleared the property once on July 28, 2009. On January 12, 2010, Mr. Lawrence was directed to cover over some additional broken windows, which he did by February 11, 2010.

The current case began September 2011. The property was boarded over and had a deteriorated appearance in the community. The overgrowth had been controlled up to that point, but on March 21, 2012 Mr. Lawrence was sent a letter requesting that he clear the overgrowth and repair the chain link fence. He did not comply and a Notice of Violation was issued on April 19. A Notice of Hearing was sent on May 8, 2012. The property was mowed, but the fence remains and yard waste and debris are piled up against the fence. Mr. Strollo said he has not had any contact from Mr. Lawrence.

Mr. Strollo made his recommendations.

Mr. Leonard closed the public hearing for deliberation. He reopened the hearing to present the Board's finding.

MOTION: Mr. Devito moved, Mr. Rotondo seconded, and motion carried unanimously to find the Respondent, Henry Lawrence, in violation of the City of Palmetto Code of Ordinances as noticed; to direct the Respondent to correct the violation within seven (7) days, or by June 5, 2012; to assess administrative costs in the amount of \$407.00, plus any applicable recording fees; and, to schedule a public hearing for June 26, 2012, to determine if the violation has been corrected.

Mr. Strollo gave the Board an update on Case No. 12-03. He informed the Board that Mr. Brown paid for his Business Tax Receipt on May 3, 2012. He still owes administrative costs of \$425.00 and fines totaling \$500.00. Liens have been recorded for both. Mr. Strollo told the Board that the original Administrative Order had been amended to remove the Property ID so that liens would not be attached to the property. Mr. Brown's account number, or 900 number, was used instead.


