Mr. Leonard called the June 26, 2012 meeting to order at 6:00 p.m. followed by a moment of silence and the Pledge of Allegiance.

The roll was called. Rose Quin-Bare was absent from the meeting.

All persons wishing to speak or testify before the Board were duly sworn.

Mr. Leonard opened the public hearing.

Code Enforcement Director Bill Strollo testified that he had been sworn and that his credentials are on file with the Clerk of the Board. He reminded the Board that the case had been continued from last month at his request due to the fact the owner was trying to resolve the code enforcement issues. There are serious issues. This property is a residential rental. An individual had been sleeping in a shed. The communal cooking area had gas and electrical hazards, and an extension cord was run from the house to the shed and residents were hanging clothes on it. Mr. Strollo asked for a continuance because the owner has cooperated. A wooden shed condemned by the Building Department has been taken down. The communal kitchen has also been demolished. He has met with the contractor who has been hired to rehab the structure. They are continuing to make progress, but because the violations are so serious, he does not want to drop the case yet. He asked to continue the case to the next meeting.

Mr. Leonard closed the public hearing.

MOTION: Mr. Hoffmann moved, Mr. Rotondo seconded, and motion carried unanimously to continue Case 12-04 to the next regular meeting.

B. Case No. 12-05 Henry Lawrence 2110 2<sup>nd</sup> Avenue East Palmetto, FL 34221

Violation Location: 401 17th Street West, Palmetto, Florida

Codes Violated: Palmetto Code of Ordinances, Chapter 7, Article XI, Section 7-242(a); Chapter 16, Health and Sanitation, Article II Nuisances, Section 16-26, Section 16-26 (2), (3) & (4) and Section 16-27(a), (b), & (c):

Mr. Leonard opened the public hearing.

Mr. Strollo testified that he had been sworn and that his credentials are on file with the Clerk of the Board. He reviewed the case. This case first came to the Board on May 29, 2012. The property has a dilapidated fence and is covered in dead vegetation and weeds and contains garbage and debris in and around the yards. The fence is overgrown. The Board found the Respondent in violation of the Palmetto Code of Ordinances and the Order directed him to bring the property into compliance by June 5, 2012. Administrative costs of \$407.00 plus applicable recording fees were assessed, and a second public hearing was scheduled for June 26, 2012. Proof of service was received for the Administrative Order.

Mr. Strollo informed the Board that the grass was cut, but the issues of the fence and overgrowth remain. Debris is spilling over onto the sidewalk. The property is basically in the same condition. Mr. Strollo said he has not had any contact with Mr. Lawrence. The property is not in foreclosure. Mr. Strollo said he recommended a fine.

Mr. Leonard closed the public hearing for deliberation. He reopened the hearing to present the Board's finding.

MOTION: Mr. Rotondo moved, Mr. Hoffmann seconded, and motion carried unanimously to find that the Respondent, Henry Lawrence, violated the Code of Ordinances as noticed; to find that the Respondent did not correct the violation within the date and time specified in the Administrative Order dated May 29, 2012; and, to impose a fine of \$50.00 per day, commencing July 5, 2012 and continuing until the violation is corrected.

#### 5. NEW BUSINESS

Mr. Strollo informed the Board that the legislature amended Code Enforcement's noticing procedures, and he has asked Mr. Persson to review. He will also be seeking the City Attorney's review. The return receipt is no longer required and a thirty-day time period was imposed before the property can be posted. This could significantly delay cases being heard before the Board.
