PROBLEM:

Matt Sfirakis is seeking Commission's approval to host a live wrestling event one Saturday of each month on the grounds of Chris' Catering Service, 120 7th St. W.

BACKGROUND:

Matt Sfirakis is seeking approval to host a monthly live wrestling event of the World Wrestling Entertainment Developmental Group of Florida Championship Wrestling. The event will be held on the grounds of Chris' Cater Service (the old Hanger Restaurant). As this is the first event in this area, attendance is estimated to be between 100 and 500. A date for the first event will not be set until approval for the event is granted by Commission.

The event will utilize a PA system to announce the wrestlers, which requires approval of a Noise Exception Permit. Mr. Sfirakis plans to place the speakers directionally east and southeast, away from the adjacent mobile home park. It is also his belief that the wooden privacy fence surrounding the property will help to mitigate the noise.

Four port-o-lets will also be set up on the private property of the catering business. Sec. 6.11.A of the Appendix B-Zoning requires approval of a Temporary Use Permit if portable restrooms are placed on any property for more than five (5) days, whether consecutive or sporadic, in one calendar year. As this event is currently planned to occur once each month, approval of a Temporary Use Permit is necessary.

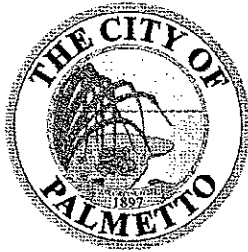

I AM AWARE THAT in determining whether or not an SPE shall be issued, the City Commission shall, at a minimum, consider the nature of the event; its possible adverse effects; its importance to the general community and potential benefit the event may have upon the City and the general public; the number of participants at the event; the time of the event; proposed effective mitigation mechanisms; and the availability of alternative locations. Review of a denial of an SPE shall be to the Circuit Court in and for Manatee County and must be filed within thirty (30) days of the date of the City Commission decision relating to the SPE. Review shall be based solely upon the record generated before the City Commission. The burden is upon the applicant to establish by substantial, competent evidence that the activity for which the SPE is sought has the means to effectively mitigate potential adverse effects and impacts upon surrounding property owners and residents.


