POINT PAPER
Congestion Management System – Available funding

Background: The MPO has grant funding available to address traffic management and congestion. This funding will allow for the identification, analysis and improvement of problem intersections, with a ceiling of \$800,000 per intersection.

Problem: The City of Palmetto is significantly impacted by traffic congestion, especially during rush hour. During peak hours, the City serves as a thoroughfare to residents of surrounding cities and counties, as well as to our own residents.

Staff has identified and received (CMS) funding to address congestion and safe mobility for the intersections located at 10th Street and 10th Avenue West, 10th Street and 14th Avenue West, and Haben Boulevard (90 degree turn). TRIP funding has also been secured (CRA) for potential upgrades to Riverside Dr. and 8th Ave.

A power point presentation is attached outlining project limits, cost analysis, and specified funding approved to date.

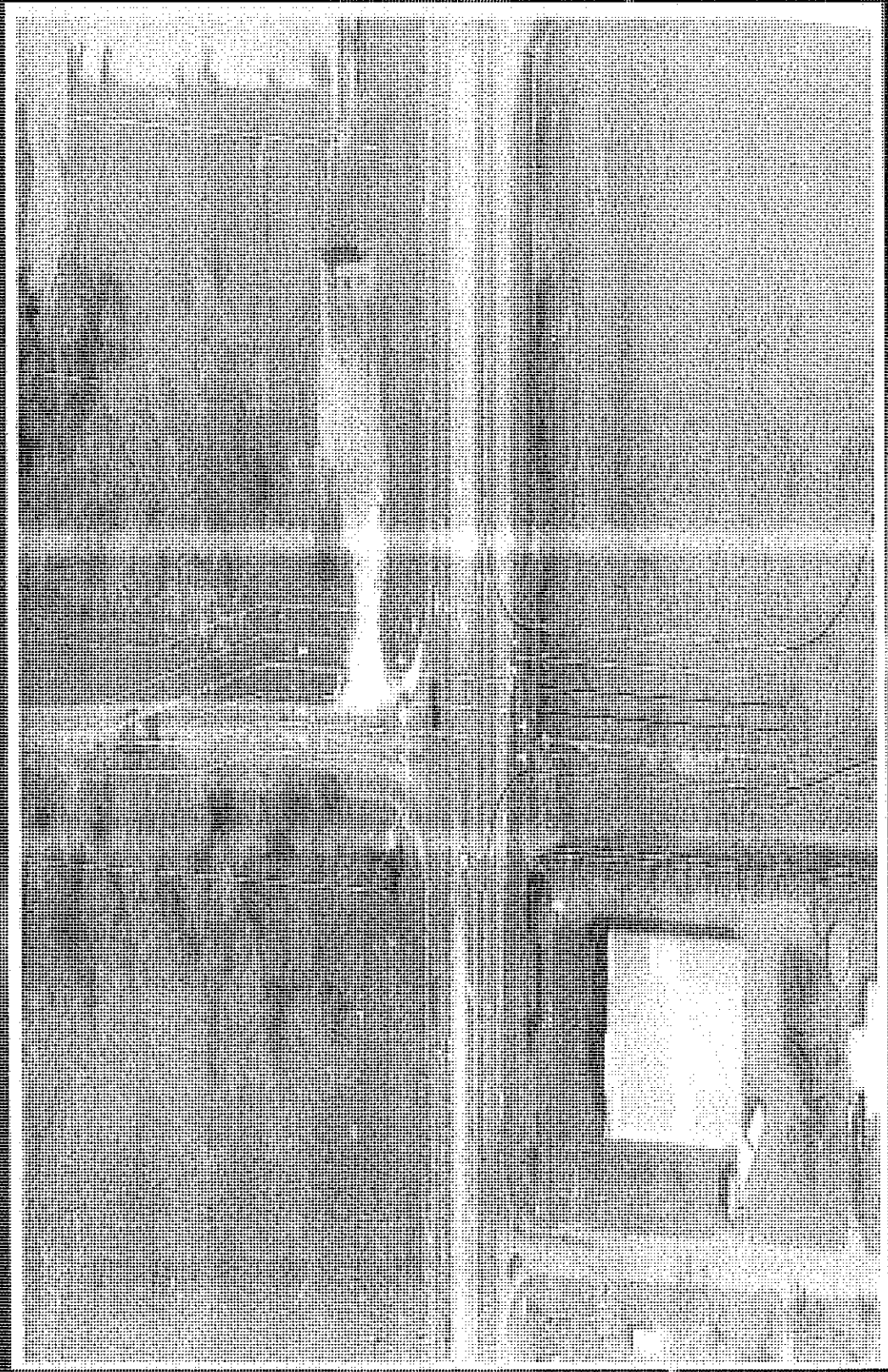
10th Street W & 14th Ave W

- Funded \$600,000 in FY 11-12
- Funding provided for construction of full signalization at intersection
- Balance of project cost to be borne by developers
- Project on hold pending FDOT approval?

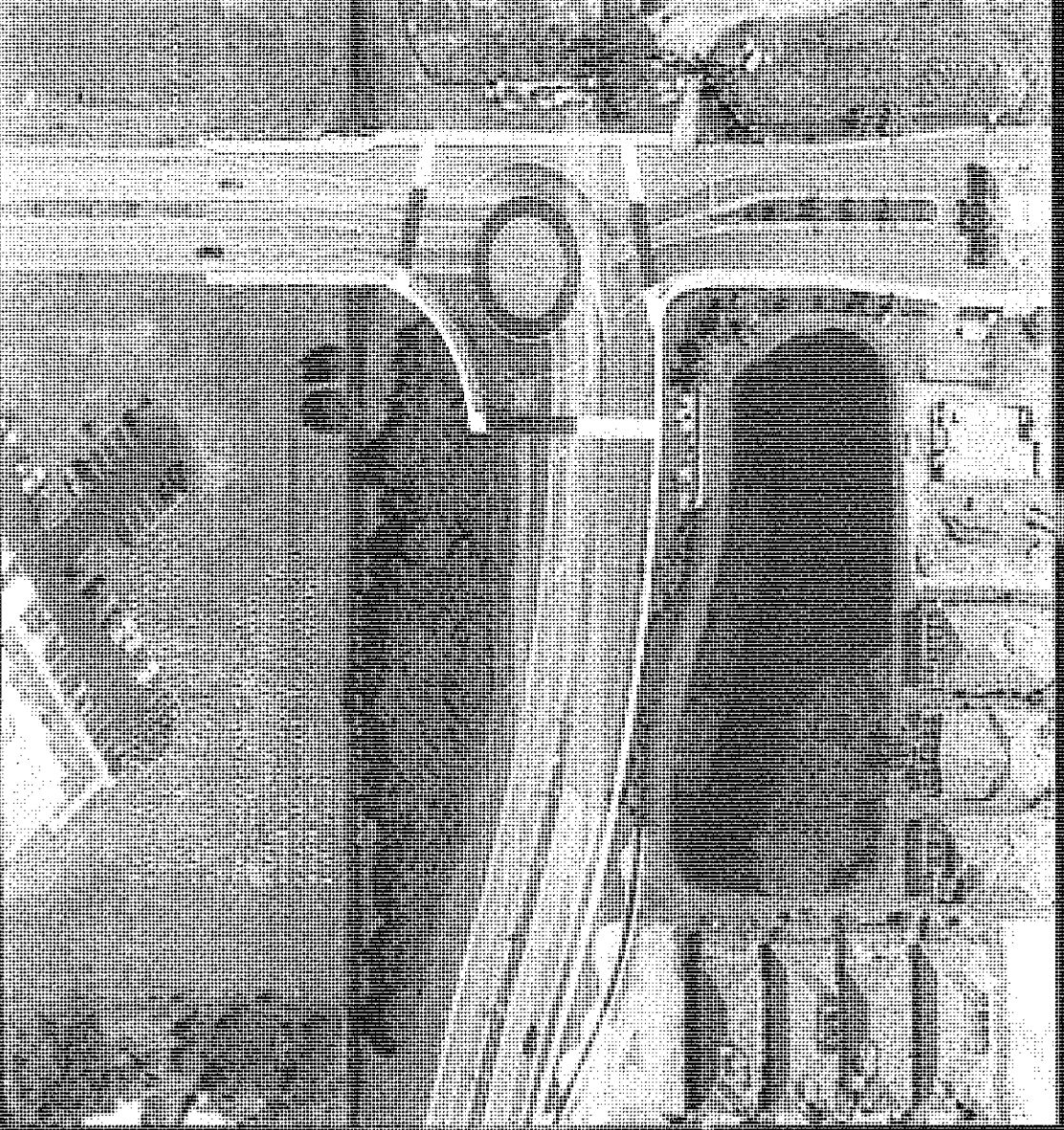
16th Avenue (Canal Rd.) & US 301



Haben Boulevard Roundabout

- Congestion Management System Project (CMS)
- Funded \$367,000 in FY 09-10
- Funding provided for construction of roundabout at 90° "curve" on Haben Blvd. at the entrance to Riviera Dunes
- Improve safety and traffic flow near Riviera Dunes, the Civic Center, the Courtney and Manatee School for the Arts

Haben Boulevard Roundabout



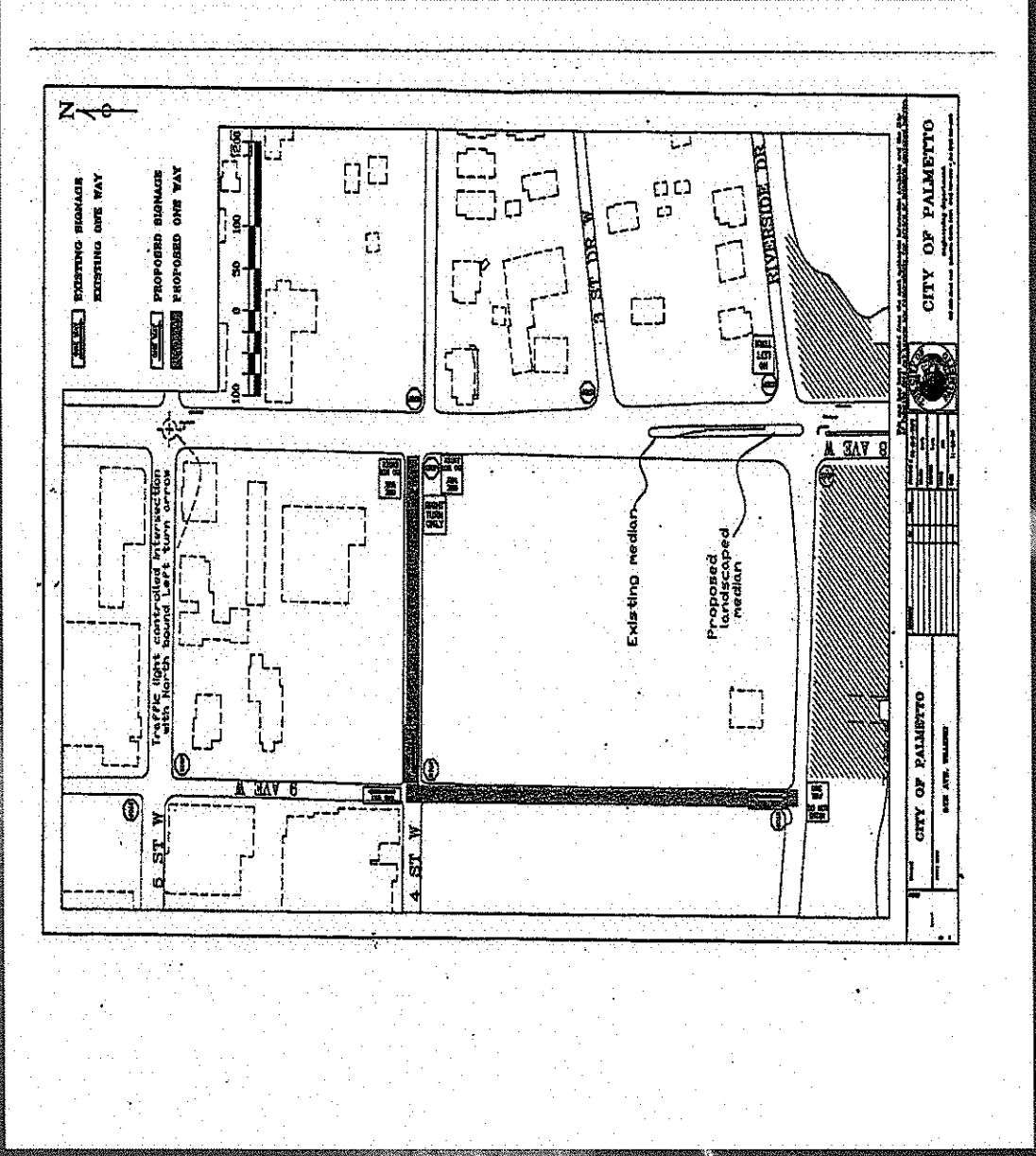
Mobility Study

- Joint project between Palmetto, Manatee Co. & the City of Bradenton
- \$607,982 funded FY 09-10
- Renaissance Planning Group recently received contract approval to perform the study.

Riverside Drive & 8th Ave.

- Transportation (TRIP) Project
- \$150,000 matching dollars provided for FY 06 – 07 (This project was extended)
- ORA to provide matching funds
- Funding for construction of intersection improvements to improve safety and traffic flow, especially as caused by eastbound Riverside Dr. traffic crossing 8th Avenue to head north.
