**Budget Amendment**

**Problem:** To establish budget for the execution of FDOT – Highway Maintenance Contract, Resolution 09-07.

**Background:**

The State of Florida Department of Transportation provides funding to maintain the right of ways on state roads within the city limits. The budget amendment increases the revenue based on two quarterly payments that will be invoiced in FY09. See below for explanation:

**RESOLUTION NO. 09-08**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PALMETTO, FLORIDA, AMENDING RESOLUTION NO. 08-32, WHICH RESOLUTION ADOPTED THE BUDGET FOR FISCAL YEAR 2008-2009, AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS, from time to time it is necessary to increase or decrease revenues and expenditures in certain accounts, and;**

**WHEREAS, it is necessary to provide budgetary authorization for the expenditure of these funds;**

**NOW, THEREFORE, BE IT RESOLVED, BY THE CITY COMMISSION OF THE CITY OF PALMETTO, FLORIDA:**

**Section 1:** That Revenue Account 307-343-2000, FDOT Highway Maintenance Contract, for the fiscal year ending September 30, 2009 is increased by Two Thousand eighty-four dollars (\$2,084), to increase the budget for the increased in funding for the Highway Maintenance Contract.

**Section 2:** This Resolution shall become effective immediately upon its passage.

**Section 3:** All Resolutions and parts of Resolutions in conflict herewith are repealed.
