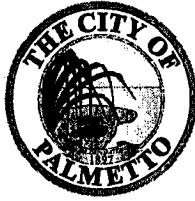
**Palmetto Bed and Breakfast has requested that two City streets be closed for Wedding ceremonies on five different dates, they are as follows.**
