A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PALMETTO AUTHORIZING MAYOR SHIRLEY GROOVER BRYANT TO APPLY TO THE FLORIDA DEPARTMENT OF COMMUNITY AFFAIRS (DCA) FOR APPROVAL OF THE CITY OF PALMETTO'S COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG)-NEIGHBORHOOD REVITALIZATION CATEGORY FFY 2009/2010 APPLICATION, ADOPTING THE PALMETTO COMPREHENSIVE PLAN AS THE CITY'S COMMUNITY DEVELOPMENT PLAN, AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, The City of Palmetto is experiencing a need for Physical Improvements in one or more low and moderate-income citizen neighborhoods; and

WHEREAS, it is the desire of the City Commission that local residents be assisted in creating an improved living environment in these areas.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF PALMETTO, FLORIDA:

SECTION 1. That the Florida Small Cities Community Development Block Grant (CDBG)-Neighborhood Revitalization program is declared to be a Workable Program for providing a need for physical improvements in the low and moderate-income area(s) indicated in the proposed FFY 2009/2010 CDBG- NR Application.

SECTION 2. The City Commission hereby directs the Mayor, or Vice-Mayor in her absence, to sign all necessary certifications of the Florida Small Cities Community Development Block Grant (CDBG)- Neighborhood Revitalization FFY 2009/2010 CDBG Application.

SECTION 3. The City Commission directs the Mayor, or Vice-Mayor in her absence, to execute and submit the attached applications to the Florida Department of Community Affairs (DCA) for state approval.

SECTION 4. That the Mayor, or Vice-Mayor in her absence, is authorized and directed to submit additional information in a timely manner as may be required by the Florida Department of Community Affairs (DCA) during the application review process and after execution of a contract agreement with the Department.

SECTION 5. The proposed FFY 2009/2010 CDBG- NR Application is consistent with the City of Palmetto Comprehensive Plan.

SECTION 6. The City of Palmetto's Comprehensive Plan is hereby adopted as the City's Community Development Plan.

SECTION 7. The City of Palmetto is committing \$125,000 to the project as Leveraged Funds.
