2010-35 BUDGET AMENDMENT Ward 1 Phase 2A

PROBLEM: Budget needs to be established for the Ward 1 Phase 2a project.

BACKGROUND: On October 4, 2010 Commission approved the award of Ward 1 Phase 2 to Gator Grading and Paving LLC for an amount not to exceed \$2,277,764.50 and on November 1, 2010 Commission authorized the Mayor to execute the contract. The project was broken up into 2 parts with the CRA providing funding in whole for Part A and partially for Part B via a transfer of \$1,587,765 made on September 27, 2010. Included in this figure is a \$60,000 administrative fee payable to Clark Communities Inc. The remaining balance will be funded through a CDBG Grant in the amount of \$750,000. The City is awaiting a notice to proceed from the State in regards to these funds that is anticipated around December 20th. A budget amendment for Part B will be brought to Commission at that time.

The CRA transferred it's portion of the funding during Fiscal year 2010 into the Water/Sewer fund where it remains as part of restricted/reserved fund balance. In order to proceed with Part A these funds need to be transferred to proper funds as listed on the winning bid. To do so, budget for the transfers and expense accounts needs to be established. Budget for Part A will be as follows:
