Installation of new FIOS Internet circuit The city has experienced some intermittent speed problems with our internet connection in recent months. We have tried trouble shooting these issues with Bright House, but have been unable to resolve the issue. In January 2007, the City signed a 3 year agreement with Bright House to provide a 10 Mbps fiber internet connection for \$350/mo. This agreement expires on January 23, 2010. As part of our due diligence, Verizon FIOS has offered to provide a 35Mbps fiber connection for \$178.98/mo. This connection is three times faster and half the price. There is also a one time \$199.98 installation fee and a 2yr. term. Staff feels the FIOS connection is the best option for the City as it will increase our internet speed and save money. We have notified Bright House of our intent not to renew and they will allow us to go month to month until the FIOS connection is installed. We estimate the FIOS circuit will be installed by early February. Funds for the internet connection have been budgeted for the current year. Once the new circuit is installed the monthly cost will be lower than the amount initially budgeted. As a result, this should save the City about \$1,190 (\$170x7 months) in the current year.
