On December 13, 2010 the City adopted its first Budget Policy. This policy provides for the strategic planning process and defines it as a comprehensive and systematic management tool designed to help the City asses the current environment, anticipate and respond appropriately to changes in the environment, envision the future, increase effectiveness, develop commitment to the City's mission and achieve consensus on strategies and objectives for achieving that mission. The strategic plan should provide a long-term perspective for service delivery and budgeting, while establishing logical links between authorized spending and broad organizational goals. The City's objectives for a strategic plan will help determine how the resources available can be tied to the future goals, and assist in the preparation of a long-term financial plan.  The City Commission will establish a strategic plan, along with the City's stated mission and objectives for achieving that mission. The City's stated Mission Statement is "The City of Palmetto is dedicated to enhancing the quality of life of its citizens by providing those services which ensure a safe and healthy community. A 3 - 5 year plan along with goals and objectives needs to be determined to guide staff in the							
development of next year's budget.  The first step in strategic planning is to determine the long term direction of the city and then decide short term goals and objectives to achieve that direction. Discussion points have been included in Attachment A to assist in the development of the plan, goals and objectives. A plan need not be development for all the points and some may be combined. These points are simply to facilitate the discussion.  This is the first time the City has undertaken the strategic planning process that normally takes some time to develop. Budget packets will be given to the departments before the end of April, and guidelines are needed from Commission to assist in the development of the budget.
