The proposed Ordinance 2012-05 greatly expands matters which can result in the finding of a public nuisance for premises. It now includes premises where crimes related to drug sale and possession, criminal gang activity, dealing in stolen property, and prostitution have occurred on a site. Further, pain management clinics found in violation of certain criminal laws can be found to be public nuisances. The Criminal Nuisance Abatement Board (the City has another Nuisance Abatement Board relating to housing) composition has been modified from the current Ordinance to avoid possible dual office holding and sunshine issues.

CITY OF PALMETTO ORDINANCE NO. 2012-05

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF PALMETTO, FLORIDA, AMENDING THE CODE OF ORDINANCES TO REVISE PROVISIONS RELATED TO CRIMINAL PUBLIC NUISANCES AND THE CRIMINAL NUISANCE ABATEMENT BOARD; PROVIDING FOR REPEAL OF ORDINANCES IN CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Article VIII, Section 2 of the Florida Constitution provides that municipalities shall have governmental, corporate and proprietary powers to enable municipalities to conduct municipal government, perform municipal functions, and render municipal services; and

WHEREAS, Chapter 166, Florida Statutes, the "Municipal Home Rule Powers Act," implements the applicable provisions of the Florida Constitution and authorizes municipalities to exercise any power for municipal purposes, except when expressly prohibited by law and to enact ordinances in furtherance thereof.

WHEREAS, Section 893.138, Florida Statutes, authorizes local governments to establish nuisance abatement boards to aid in abating drug-related, prostitution-related, stolen property-related or criminal gang-related activity.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF PALMETTO, FLORIDA, AS FOLLOWS:

Section 1. <u>Amendment of Chapter 20, Article II of the City of Palmetto Code of Ordinances.</u> Chapter 20, Article II, of the City of Palmetto Code of Ordinances is hereby amended to read in its entirety as follows:

(c) When used in this Article, the term "place" or "premises" shall be defined as the extent of fee ownership. For example, a multi-unit residential facility under common ownership shall be considered a single "place" or "premises", whereas a multi-family residential facility under condominium ownership shall be reviewed on a unit-by-unit basis.

Section 20-52. - Complaint Procedures.

- (a) Any employee, officer, or resident of the city may file a complaint with the city police department alleging the existence of a Public Nuisance as defined in Section 20-51, after first giving not less than three (3) days written notice of such complaint to the owner of the premises sent via Certified Mail or hand delivered, to owner's last known address.
- (b) Upon the receipt of a complaint alleging activity meeting the definition of public nuisance in Section 20-51, and complying with the notice provisions contained herein, the Chief of Police shall investigate the allegations and, if warranted, shall request a hearing before the Criminal Nuisance Abatement Board by providing notice to the City Clerk with a copy to the Mayor and City Attorney.
- (c) Upon receipt of such request for hearing, the clerk of the Criminal Nuisance Abatement Board shall schedule a hearing, and shall provide the owner of the premises with a minimum of fourteen (14) <u>calendar</u> days written notice, sent via certified mail or hand delivered to the owner of the premises. The notice shall include a statement of the time, place and nature of the hearing, a reference to the specific sections of the ordinance or Florida Statutes alleged to have been violated, and a brief statement summarizing the facts underlying the allegations.

<u>Section 20-53. – Establishment and Composition of the Criminal Nuisance Abatement</u> Board.

The Criminal Nuisance Abatement Board is hereby established to carry out the duties and powers ascribed to it in this Article. The Board shall consist of five (5) members to be appointed by the Mayor and approved by a majority vote of the City Commission. The terms of the office shall be for two (2) years from the date of their appointment, except that the initial terms of two (2) members shall be only one (1) year from the date of their appointments. All subsequent terms shall be for two (2) years. Any vacancy occurring during the term of any member of the board shall be filled for the unexpired portion of the term. Any person who resides or is engaged in business, which means owning a business, practicing a profession, or performing a service for compensation, or serving as an officer or director of a corporation or other business entity so engaged, within the city shall be eligible for appointment to the Criminal Nuisance Abatement Board.

receive and consider hearsay or other evidence not admissible under the Florida Rules of Evidence.

- (b) At the conclusion of the hearing, the board may declare the place or premises to be a public nuisance as defined in Section 20-51, and may enter an order:
 - 1. Immediately prohibiting the maintaining of the nuisance;
 - 2. Immediately prohibiting the operating or maintaining of the place or premises, including the closure of the place or premises or any part thereof; or
 - 3. Immediately prohibiting the conduct, operation or maintenance of any business or activity on the premises which is conducive to such nuisance.

The Chief of Police, or his designee, shall notify the Commission of any action taken by the Board.

(c) An order entered under subsection (b) shall expire after one (1) year or at such earlier time as stated in the order.

Section 20-57. - Enforcement.

- (a) An order of the Criminal Nuisance Abatement Board may be enforced by any or all of the following procedures:
 - 1. The City may pursue enforcement pursuant to the provisions contained in Section 120.69, Florida Statutes
 - 2. The City may bring a complaint under Section 60.05, Florida Statutes, seeking temporary and permanent injunctive relief.
 - 3. The City may bring an enforcement action before the Criminal Nuisance Abatement Board. An enforcement action before the Criminal Nuisance Abatement Board shall follow the notice provisions in Section 20-52(c) and the hearing procedures in Section 20-56(a).
- (b) Upon a finding by the court or by the Criminal Nuisance Abatement Board that an order issued pursuant to Section 20-56(b) has been violated, the following penalties may be imposed by the Board, in addition to the other remedies available at law:
 - 1. Imposing fines not to exceed \$250 per day.
 - 2. Requiring the payment of the reasonable costs, including reasonable attorneys fees, associated with the investigations of and hearings related to the public nuisance.
 - 3. Providing for continuing jurisdiction for a period of one (1) year over any place or premises declared to be or have been a public nuisance.
 - 4. Imposing fines not to exceed \$500 per day for recurring public nuisances.
 - 5. Providing for the recording of the order so that notice must be given to subsequent purchasers, successors in interest, or assigns, of the real property that is subject to the order.
