RESOLUTION NO. 2012-16

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PALMETTO, FLORIDA, AMENDING RESOLUTION NO. 2011-31, WHICH RESOLUTION ADOPTED THE BUDGET FOR FISCAL YEAR 2011-2012, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, from time to time it is necessary to increase or decrease revenues and expenditures in certain accounts, and;

WHEREAS, it is necessary to provide budgetary authorization for the expenditure of these funds;

NOW, THEREFORE, BE IT RESOLVED, BY THE CITY COMMISSION OF THE CITY OF PALMETTO, FLORIDA:

Section 1: That Revenue Account 001 331 2400 9017 PD Rapid ID/Interview Rm-Revenue, for the fiscal year ending September 30, 2012 is increased by Fifteen Thousand Eight Hundred and Seven Dollars (\$15,807) to provide budget for the Rapid ID and Interview Room Project Grant.

Section 2: That Expense Account 001 701 3101 9017 PD Rapid ID/Interview Rm-Revenue, for the fiscal year ending September 30, 2012 is increased by Twelve Hundred and Fourteen Dollars (\$1,214) to provide budget for the Rapid ID and Interview Room Project Grant.

Section 3: That Expense Account 001 701 6401 9017 PD Rapid ID/Interview Rm-Revenue, for the fiscal year ending September 30, 2012 is increased by Fourteen Thousand Five Hundred and Ninety-Three Dollars (\$14,593) to provide budget for the Rapid ID and Interview Room Project Grant.

Section 4: This Resolution shall become effective immediately upon its passage.

Section 5: All Resolutions and parts of Resolutions in conflict herewith are repealed.
