

**MEMORANDUM OF UNDERSTANDING**

This Memorandum of Understanding is entered into by and between the Manatee County Sheriff's Office by the undersigned Sheriff, and the Bradenton Police Department, the Bradenton Beach Police Department the Holmes Beach Police Department, the Longboat Key Police Department and the Palmetto Police Department in furtherance of their respective duties under law and for the purpose of sharing radio communications. The undersigned Sheriff and each individual agency head (Police Chief) agree as follows:

1. The Manatee County Sheriff's Office agrees to share the listed groups 11 - 18 with the other named agencies.
2. The Bradenton Beach Police Department agrees to share the listed groups 44, ISL EOC, ISL TACT with the other named agencies.
3. The Bradenton Police Department agrees to share the listed groups 41 and 42 with the other named agencies.
4. The Holmes Beach Police Department agrees to share the listed groups Patrol and TACT with the other named agencies.
5. The Longboat Key Police Department agrees to share the listed groups Patrol and TACT with the other named agencies.
6. The Palmetto Police Department agrees to share the listed groups Dispatch and TACT with the other named agencies.

This Memorandum of Understanding represents the entire agreement between the parties on this subject matter. Any alteration or amendment of the provisions of this agreement shall be in writing, duly signed by authorized personnel of each of the parties and attached to the original of this agreement.


This agreement shall become effective upon execution by the parties and may be terminated upon thirty (30) days notice by mutual agreement of the parties.






