RESOLUTION NO. 2019-10

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PALMETTO, FLORIDA, AMENDING RESOLUTION NO. 2018-28, WHICH RESOLUTION ADOPTED THE BUDGET FOR FISCAL YEAR 2018-2019, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, from time to time it is necessary to increase or decrease revenues and expenditures in certain accounts, and;

WHEREAS, it is necessary to provide budgetary authorization for the expenditure of these funds;

NOW, THEREFORE, BE IT RESOLVED, BY THE CITY COMMISSION OF THE CITY OF PALMETTO, FLORIDA:

Section 1: That Revenue Account 001-000-337.0200-9031, Waterway Development Grant, for the fiscal year ending September 30, 2019 is increased by Fifteen thousand dollars (\$15,000) to provide

Section 2: That Expense Account 001-703-763.0100-9031, Waterway Development Grant, for the fiscal

year ending September 30, 2019 is increased by Fifteen thousand dollars (\$15,000) to provide

Section 3: This Resolution shall become effective immediately upon its passage.

Section 4: All Resolutions and parts of Resolutions in conflict herewith are repealed.
