Discussion: Lt. Tyler discussed the recent shooting and how the case can be helped by

CRA initiative in the community policing sub-plan to match the Manatee County Crimestoppers "tip" money in support of the effort to solve major crimes within the CRA district. During discussion, Mr. Burton stated that the matching funds program has been approved by both CRA boards. He also pointed out that "reward" signs will be printed and posted, in an effort to have witnesses come forward. Further discussion ensued regarding things that the CRA can do, including a reward poster, to deal with the recent incident and future crime.

Action: Nick Costides moved to recommend that Mr. Burton discuss with the

Mayor the possibility of expediting a program to spend significant funds

for the security of the city with an eye toward cameras.

4. Suncoast Community Capital - Mike Kennedy Executive Director Suncoast Community Capital

Discussion:

Mr. Kennedy provided an overview of the mission and services provided by Suncoast Community Capital, a non-profit organization that specializes in assisting entrepreneurs through training, and helping with access to capital and providing other resources. Suncoast Community Capital is working with the Manatee Community Federal Credit Union on micro-loans and also with the

Kauffman Foundation and its Urban Entrepreneurship program.

Action: Given that the FY2012 budget is already set, the consensus was that the

opportunity for CRA involvement with Suncoast Community Capital and its

partners be considered again at a future meeting.

5. Residential Rehabilitation Plan – Amended Presentation

Discussion:

Mr. Burton gave an update on the current program and explained the changes to the Residential Rehabilitation Plan, to include added definitions, a revised goal statement, and a provision for Code Enforcement verification. Further adjustments to the plan were discussed, including Mr. Costides' suggestion to

add a statement saying that the owner must have the ability to fund required upkeep after rehabilitation is completed.

Rehabilitation Plan, with the change suggested by Mr. Costides.

6. 4th of July, 2012 Presentation

Discussion:

Mr. Burton presented a detailed summary of costs for the 2011 4th of July concert and celebration.
