## 1. CRA ADVISORY BOARD AGENDA APPROVAL.

Action: Nick Costides moved to approve the October 11, 2011 agenda.

Vote: Motion carried by unanimous vote.

## 2. APPROVAL OF SEPTEMBER 13, 2011 MINUTES.

Action: Charles Smith moved to approve the September 9, 2011 minutes.

Seconded by Nick Costides.

Vote: Motion carried by unanimous vote.

## **NEW BUSINESS**

#### 3. Palmetto Art Center (Gold Commercial Investments Inc.) Storefront

**Discussion:** The grant request is for replacement of windows, soffit and fascia. Mr. Costides expressed concern that the store front grant program should result in a noticeable improvement in a building's appearance and that it currently reimburses for some improvements that do not accomplish that objective. Mr. Burton agreed that revisions should be considered in the future.

Action: Nick Costides moved to approve the Storefront Grant request.

Second by Charles Smith.

Vote: Motion carried by unanimous vote.

Discussion ensued about increasing awareness by more businesses of opportunities available through the CRA. Mr. Burton stated that the CRA brochures will be ready soon, he plans to do a

survey to gather data for the CRA and for the Economic Development Council, and he would like to develop packets of information tailored to the respective use code areas within the CRA.

# 4. Storefront CPTED (Crime Prevention Through Environmental Design) Provision

**Discussion:** Mr. Burton discussed adding a provision to the Store Front Grant program to provide incentives for businesses to install technical innovations based on Crime Prevention through Environmental Design (CPTED), with the CRA granting 75% of the cost of installation, with a maximum of \$10,000.

Action: Nick Costides moved to recommend the CPTED addition to the Store

Front Grant Program, with a word change from "maintenance" to

"CPTED" on line 2 paragraph 2. Seconded by Sia Mollanazar.

Vote: Motion carried by unanimous vote.

# 5. <u>Kingpin Non-Violence Training (Community Policing)</u>

**Discussion:** Mr. Burton stated that, in response to an interest expressed by the mayor and police chief in providing appropriate training in light of recent incidents in the community, the CRA recommends the Kingian Non-Violence Training. It will be provided in by Manny Rivero from the Jim Walter Partnership Center at USF and funded by community policing funds.

### 6. Community Leadership in lieu of multicultural event

**Discussion:** There was discussion about the pros and cons of cancelling the multi-cultural event and concert planned for the Martin Luther King holiday and replacing it with a special leadership development initiative, in response to shootings that have occurred. Also discussed, was when CRA funds can or cannot be used in support of certain community events.
