4. COMMUNITY POLICING INITIATIVE PLAN BUDGET

Chief Tyler gave a PowerPoint presentation, which is attached and made a part of these minutes. Chief Tyler described Universal Crime Rate (UCR) as the common benchmark to measure the effectiveness of policing. He defined Part 1 crimes and talked about CRA allocations to fund police, in order to decrease Part 1 crimes. He commented CRA officers specifically assigned to the CRA district are being proactive, reactive and interactive with the community. He talked about current police programs as well as innovative programs being developed.

Mrs. Gaulien offered thanks for all the Police Department does for the community. Mr. Washington and Mr. Gonzalez both added supportive comments.

5. PALMETTO CRA 2016-2017 BUDGET

The Board reviewed the proposed budget. Mr. Washington suggested any surplus funds should go to the Police department for their needs. Mrs. Gaulien requested additional funds for sod at Haben Blvd to finish landscape.
