#### 5. INVESTMENT REVIEW

Mr. Owens, Graystone Consulting, gave an economy and market review over the last quarter, noting that this quarter and last quarter were very similar.

Mr. Mulfinger, Graystone Consulting, commented that this quarter was a very positive quarter. The Portfolio was valued at \$13,215,325, a gain net-of-fees of \$375,923. Equity was weighted at 63.83%, slightly over the 60.00% mark; but within the range of 60-65% as written in the Investment Policy Statement. Mr. Mulfinger did not recommend a rebalance at this time.

Mr. Mulfinger gave a review of each manager's performance for the quarter and comparing them against the benchmark. The dollar-weighted net return for the quarter was 2.74 percent.
