4. REZONE ORDINANCE NO. 2018-30 (K. OWENS)

(TAB 2)

AN ORDINANCE OF THE CITY OF PALMETTO, FLORIDA REZONING APPROXIMATELY .27 ACRES OF PROPERTY GENERALLY LOCATED AT 819 7TH STREET WEST, PALMETTO, FLORIDA, FROM RM-6 TO CN, NEIGHBORHOOD COMMERCIAL, AND AS MORE PARTICULARLY DESCRIBED IN THIS ORDINANCE; PROVIDING FOR SEVERABILITY, AND AN EFFECTIVE DATE. (MANGO TREE GROUP, LLC)

There was no public comment for this item. The applicant or representative was not present.

Mrs. Owens explained that the subject property was damaged by a tree during hurricane Irma. The company that purchased the property would like to use it for office or personal services. Mrs. Owens explained that she recommends rezoning to CN (Neighborhood Commercial), which allows for personal services, GO (Commercial Office) doesn't allow personal services. The proposed Circle K will be located to the east of the subject property. The property owner will be responsible for the off-street parking of the site. Mrs. Owens explained it will be self-limiting, as the required parking will be determined by the use. The business owner will be required to go through site plan review, which goes through staff administratively.

Mrs. Owens explained some of the examples of personal services as being hair salon, nail salon, massage therapist.

Mrs. Owens will have Mango Tree Group, LLC execute a new ownership affidavit as the one on file is before they owned the property, and was signed by the previous owner.
