Code Enforcement Officer Don Barajas stated Mr. Bonelli fixed the violations on the property, paid the water bill, as well as satisfied the code and utility liens, so the property is no longer out of compliance.

Code Enforcement Officer Don Barajas stated the respondent bought the property with an existing fence, and the only addition he did was add barbed wire, but Mr. Ritchie removed the barbed wire immediately. Mr. Barajas said he closed the case because it was in the previous owner's name. He confirmed that no fence permit had been submitted.

Magistrate Kardash clarified that Mr. Ritchie had attended the Code Enforcement Hearing in May. The change of ownership had been established at that hearing and Mr. Ritchie was aware that he needed to submit an after-the-fact permit as well as a permit for the additional fence installation.

Mr. Chad Ritchie restated that Florida Power and Light (FPL), and USA Fencing are both working on the property. He stated FPL finally removed the trees yesterday, and USA fencing will soon be contacting the City for the appropriate permits.

STIPULATION: Magistrate Kardash issued a compliance date, and gave the

Respondent until Monday, July 26, 2021 to apply for a permit. There will be a finding of violation at the next hearing on July 27, 2021.
