Mayor Bustle called the meeting to order at 7:03 PM.

Mayor Bustle gave an invocation, followed by the Pledge of Allegiance to the United States Flag.

Commissioner Mary Lancaster, Chairperson, and Faye Butler, Founder of the GTP Sickle Cell Foundation, accepted a Proclamation read by Mayor Bustle declaring September 1, 2005 Sickle Cell Awareness Day in the City. Commissioner Lancaster invited the Commission and public to the September 1, 2005 grand opening of the Foundation.

PUBLIC COMMENT:

Allen Tusing, representing Zirkelbach Construction, requested Commission permit a variance to the City's noise ordinance by allowing the delivery of concrete to the company's office site located at 1415 10th St. W. Mr. Tusing presented acknowledgment from the most impacted surrounding property owners agreeing to the early morning delivery.

MOTION: Mr. Williams moved, Ms. Cornwell seconded and motion carried 5-0 to grant the variance to the City's noise ordinance.

David Ferdinand, 627 S. Osprey Ave., Sarasota, FL, spoke about the Palmetto Enterprise Night event planned for September 28, 2005. He stated the public speaking portion of the event will now be held at a City park and the entertainment portion of the event at a private residence. He also commented on the fact he has not received any comments from the Mayor or Commission concerning the event. Mr. Ferdinand explained he is expressing a desire to help bring very large capital dollars into the City.

3. PUBLIC HEARING - ORDINANCE NO. 05-862

Commissioner Williams announced he would abstain from the vote, as he will personally be affected by the decision.

Discussion: The City's Nuisance Ordinance regulates trucks with attached equipment that may be deemed dangerous. Staff will advise Commission if vehicles with attached trailers or boat trailers in excess of ten feet are meant to be regulated by Ordinance No. 05-862.

The vote on the floor carried 3-1. Ms. Varnadore voted no.

4. FINAL PLAT APPROVAL - RIVERBAY TOWNHOMES PHASE III

Ms. McCann informed Commission approval of the final plat is a ministerial action of Commission, as there has been no changes made to the preliminary plat pervious approved.

8. DEPARTMENT HEADS' COMMENTS

Mr. Lukowiak

Advised Commission the Chief of Police, Fire Chief and he have been advised training that for the National Incident Management System (NIMS) must be completed by key personnel and elected officials by September 30, 2005 to apply for FEMA reimbursement. Classes have been organized into two sessions for August 30, August 31 and September 1, 9:00 AM-12:00 PM and 1:00 PM - 4:00 PM. Training and testing can also be done online.

Smoke testing begins September 1, 2005.

Mr. Lukowiak discussed the memo distributed at the beginning of the 4:00 workshop meeting concerning:

- 1. WWTP is operating in an overflow reserve line as a result of accumulated sediment occupying the fermentation tank. Cost to correct is anticipated not to exceed \$41,000. Mr. Lukowiak explained the transfer pipe is totally closed and the system is operating in by-pass flow. The last time the tanks were cleaned was in 1969. Veolia will contract for the immediate removal of accumulated sediment from the fermentation tanks at their cost; the City will reimburse the expense at the end of the current Veolia contract year, 2006.
- 2. The Cottage House in the Historic Park is being refurbished through CIP funding. It is estimated an additional \$10,000 will be necessary to complete the project.

The basement of the Carnegie Library requires a new air-conditioner, at a cost of \$4,200. This unforeseen expense is not included in the current year's budget. (Staff will determine if a grant is available before purchasing a new air-conditioner.)

3. The Parks Department proposes the installation of identification cornerstones at each block of the cemetery at a cost of approximately \$2,000.

After discussion of the topics, Commission agreed to the expenditure. Mr. Lukowiak will bring necessary documentation for each project to a subsequent meeting.

Mr. Freeman

Announced the Department Heads will be meeting tomorrow with the intention to present a balanced budget with full Cody implementation. Discussion resulted in a September 7, 2005, 6:00 PM budget meeting.

Provided the following information:

- The ZNS contract does contain planning services.
- Code Enforcement revenue is posted to the General Fund.
- Translation and hearing impaired services, as well as Spanish classes, are being researched.

Centralized cash receipting at City Hall begins Monday, September 12, 2005.

Attorney Hall

Confirmed there is no workshop meeting scheduled for September 10, 2005.

A memo regarding the expansion of a CDD has been distributed for review prior to the ordinance concerning the expansion of the Palms of Terra Ceia CDD.

Given the fact the inclusionary housing issue would have been discussed at a September 10, 2005 workshop, Attorney Hall suggested the Planning Administrator should develop a notice of pending land development regulation that puts developers on notice the City is seriously considering an inclusionary housing ordinance.

9. MAYOR'S REPORT

Reported on the MPO Southwest Florida Chairs Committee meeting. Palmetto's project, improvements at Riverside Dr. and 8th Ave. W. looks promising; \$150,000 will be funded by CRA and \$150,000 by the TRIP program. It was agreed Sarasota's Advanced Transportation Management System is the number one project; Manatee County's portion of the ATMS is funded by Skyway Bridge tolls.

10. COMMISSIONERS' COMMENTS

Ms. Varnadore

Inquired about the status of the dock ordinance, wherein a board of citizens would review issues before presentation to Commission. Attorney Hall is researching the topic, while staff has completed an inventory of lots having or seeking docks. Mayor Bustle stated he would prefer receiving staff's position before seeking public input.

Inquired about the status of the historic preservation board; she wishes to seek information on grants that may be available for historic preservation. Attorney Hall has prepared a draft ordinance and design guidelines that will be included in an administrative document.

Ms. Varnadore commented on accelerating the priority of the in-house attorney, given the amount of projected legal fees. Stated her opinion that Commission should discuss whether new policies regarding attorney fees should be implemented to lower the fees. Discussion resulted in the Agenda Item Suspense Log being placed on the September 10, 2005 agenda.

Commented on the fill ordinance and the fact not all fill is related to new construction.

Commented on her position as liaison to the 4H Foundation and the fact the foundation's new year is beginning.

Mr. Williams

Stated he would be at the NIMS training.

Stated his satisfaction with the recent FLOC conference and the following retreat.

Recognized JEA representative Claude Tankersly.

Mrs. Lancaster

Reviewed the schedule of the NIMS training. Training is available online. Commissioners can transmit the final portion to Mr. Lukowiak for verification.

Announced her main concern is meeting needs before beautification begins.

Mr. Ball

Commented on his opinion the NIMS training is not required according to the information he was given. He stated he will attend the training. Ms. Cornwell stated she wants to see the specific language from FEMA that will restrict funding if Commissioners do not attend the training.

Reminded Commission of the Toy Social at the Historic Park. Also, monthly meetings of the Palmetto Historical Commission are held the first Saturday of each month beginning at 10:00 PM, which includes a presentation regarding Palmetto's history.

Commented on attending the new urbanism seminar at the FLOC conference and how the inclusionary housing is a positive step in involving developers. He spoke of the need to move as quickly as possible in creating a Code that encourages developing a community that will be built around a central commercial core and central park.

Ms. Cornwell

Requested information that will inform Commission of items they can request when approving developments; location, demographics, children's needs, etc. Mr. Lukowiak stated the Department Heads and Attorney Hall will meet to discuss this topic and develop a list of what the City's current code can impose on developers for submittal to Michele Mellgren, the consultant preparing the EAR and Land Development Code. Attorney Hall also informed the Commission a planning firm retained by Manatee County is developing a planning theory that can be applied county wide.

The County Commission voted to install the 25 yard pool at Blackstone Park.

Staff will research implementing the requirement of fingerprinting employees.

Will supply a SWFWMD contact name for the individual handling the bracelets.

Meeting adjourned at 9:15 PM.

It applies equally to members of advisory and non-advisory bodies who are presented with a voting conflict of interest under Section 112.3143. Florida Statutes.

Your responsibilities under the law when faced with voting on a measure in which you have a conflict of interest will vary greatly depending on whether you hold an elective or appointive position. For this reason, please pay close attention to the instructions on this form before completing the reverse side and filing the form.

INSTRUCTIONS FOR COMPLIANCE WITH SECTION 112.3143, FLORIDA STATUTES

A person holding elective or appointive county, municipal, or other local public office MUST ABSTAIN from voting on a measure which inures to his or her special private gain or loss. Each elected or appointed local officer also is prohibited from knowingly voting on a measure which inures to the special gain or loss of a principal (other than a government agency) by whom he or she is retained (including the parent organization or subsidiary of a corporate principal by which he or she is retained); to the special private gain or loss of a relative; or to the special private gain or loss of a business associate. Commissioners of community redevelopment agencies under Sec. 163.356 or 163.357, F.S., and officers of independent special tax districts elected on a one-acre, one-vote basis are not prohibited from voting in that capacity.

For purposes of this law, a "relative" includes only the officer's father, mother, son, daughter, husband, wife, brother, sister, father-in-law, mother-in-law, son-in-law, and daughter-in-law. A "business associate" means any person or entity engaged in or carrying on a business enterprise with the officer as a partner, joint venturer, coowner of property, or corporate shareholder (where the shares of the corporation are not listed on any national or regional stock exchange).

ELECTED OFFICERS:

In addition to abstaining from voting in the situations described above, you must disclose the conflict:

PRIOR TO THE VOTE BEING TAKEN by publicly stating to the assembly the nature of your interest in the measure on which you are abstaining from voting; and

WITHIN 15 DAYS AFTER THE VOTE OCCURS by completing and filing this form with the person responsible for recording the minutes of the meeting, who should incorporate the form in the minutes.

APPOINTED OFFICERS:

Although you must abstain from voting in the situations described above, you otherwise may participate in these matters. However, you must disclose the nature of the conflict before making any attempt to influence the decision, whether orally or in writing and whether made by you or at your direction.

IF YOU INTEND TO MAKE ANY ATTEMPT TO INFLUENCE THE DECISION PRIOR TO THE MEETING AT WHICH THE VOTE WILL BE TAKEN:

• You must complete and file this form (before making any attempt to influence the decision) with the person responsible for recording the minutes of the meeting, who will incorporate the form in the minutes. (Continued on other side)
