PUBLIC HEARING: ORDINANCE NO. 07-932 (TAB 10) AN ORDINANCE OF THE CITY OF PALMETTO, FLORIDA, AMENDING SECTIONS 17-52(C) AND 17-54 OF THE CITY CODE OF ORDINANCES; PROVIDING FOR THE TOLLING OF DEVELOPMENT APPLICATION REVIEW DURING CITY PLANNER REVIEW OF A REQUEST FOR INCENTIVES FOR THE CONSTRUCTION OF ATTAINABLE HOUSING UNITS; PROVIDING FOR AN INCREASE IN THE OPPORTUNITY FOR DEVELOPERS TO MAKE PAYMENTS IN LIEU OF CONSTRUCTING ATTAINABLE HOUSING UNITS; PROVIDING FOR REPEAL OF ORDINANCES IN CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Mayor Bustle closed the public hearing.

Discussion: Discussion ensued on how the value of land being donated in lieu of units will be determined. Mr. Lukowiak stated he will develop the necessary procedure to provide sufficient information to allow City Commission to make an informed decision. Attorney Hall reiterated that Commission must approve all credits being granted by the City in lieu of building attainable housing units. Mr. Williams suggested a penalty or incentive should be established to encourage the construction of a home rather than the donation of land. Ms. Varnadore opined Commission is approving the insertion of the land donation option into the ordinance, not the criteria for how land should be accepted.

MOTION: Ms. Varnadore moved and Mrs. Lancaster seconded to adopt Ordinance No. 07-932.

Discussion: Mr. Williams commented on Sec. 17-52. Attorney Hall advised that in Sec. 17-52, the word "determination" should be changed to "recommendation", because nothing is final until approved by Commission.

MOTION: Mr. Williams moved and Mr. Ball seconded to amend the motion to change the two words "determination" in Sec. 17-52 to "recommendation". The amended motion carried 5-0.

Discussion: Mr. Ball questioned the language "all other development applications received pursuant to this code..." Attorney Hall explained the intent of the language and suggested more definitive verbiage may be "all other development applications received pertaining to the subject property..." Attorney Hall also explained the intent of the language pertaining to incomplete applications.

MOTION: Mr. Ball moved and Mr. Williams seconded to amend the motion to change the language "all other development application received pursuant to this code" to "all other development applications received pursuant to the subject property". The amended motion carried 5-0.

The motion on the floor to adopt Ordinance No. 07-932 carried 5-0.

10. RESOLUTION No. 07-17

Establish budget for the funding of the 7th Street signalization project.

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PALMETTO, FLORIDA, AMENDING RESOLUTION NO. 06-33, WHICH RESOLUTION ADOPTED THE BUDGET FOR FISCAL YEAR 2006-2007, AND PROVIDING FOR AN EFFECTIVE DATE.

MOTION: Mrs. Lancaster moved, Mr. Ball seconded and motion carried 5-0 to adopt Resolution No. 07-17.

11. APPROVAL: LOMBARDO, FOLEY & KOLARIK, INC. ENGINEERING SERVICES AGREEMENT (Carried forward from the 4:00 agenda)

Mr. Lukowiak confirmed the agreement's scope of services would be amended to delete the irrigation well and insert reclaimed water, which should be no difference in funding.

MOTION: Mr. Williams moved, Mr. Ball seconded and motion carried 5-0 to approve and authorize the Mayor to execute the Lombardo, Foley & Kolarik, Inc. 7th Street Work Assignment #1 in an amount not to exceed \$95,800.

12. DEPARTMENT HEADS' COMMENTS

Mr. Lukowiak No report.

Mr. Freeman

Reminded the elected officials and department heads that Form 1 must be filed by July 1, 2007.

For emergency preparedness reasons, Mr. Freeman requested that the City's Bank of America Visa credit cards limits be increased to \$2,500 and that one limit be increased to \$10,000. Mayor Bustle suggested the City Clerk's card be the one with the \$10,000 credit limit. Mr. Williams referenced emergency preparedness meetings he had attended where it was suggested cities should have a credit limit of at least \$25,000 available.

MOTION: Mr. Williams moved, Mr. Ball seconded and motion carried 5-0 to increase the City Clerk's City Visa card credit limit to \$25,000.

Reviewed the budget meeting planning calendar. Informed Commission the tentative millage rate must be approved at the July 9, 2007 Commission meeting, as the DR420 must be submitted by August 4, 2007.

The property appraiser's preliminary tax appraisal has been received and reflects a 15% increase to the taxable values, up to just over \$1 billion. The final value is due July 1, 2007.

Chief Lowe

Attorney Hall

Reported she received an email from Ridan Industries, the firm proposing a cell tower at the wastewater treatment plan, advising they are withdrawing their proposal. She informed Commission the firm stated the changes requested by the City are not economically viable and suggested the City should offer a written response that the City was not refusing any license agreement, just the one offered by Ridan. She suggested that a response from the City would be that the City did not reject any license agreement, just the agreement as prepared by Ridan.

Referring to the Olympia Theater letter mailed under the Mayor's signature, Attorney Hall stated she has received a reply from Attorney Bill Moore. Mayor Bustle stated he would like to review the letter and then will contact Commissioners individually to discuss Attorney Moore's response.

Mr. Williams

Reported he is observing in other communities the words "participation administration" in articles. He described the terminology as upper management getting involved by working street level positions. He reported Lee and Charlotte police departments are employing the terminology in their counties. He suggested the concept is something department heads should consider in their budget preparation.

Ms. Varnadore

Commented on the cancellation of the joint School Board meeting. Mayor Bustle reported his last meeting with Dr. Dearing revealed his plan to build a full size elementary school at 33rd St. W. and 8th Ave. and then a lab school at the present Palmetto Elementary School site. It is anticipated students will be attending the new school in 2008.

Reported she has heard the county put the 17th Street project on hold. Mr. Lukowiak stated Public Works has no intention of moving any utilities until necessary, but he must budget for the eventuality because he may have very short notice to proceed.

Reported the pedestrian walkway at the Snead Island Bridge will be cantilevered under the bridge; the bridge will not be narrowed.

Requested that the Risk Manager submit a written assessment of the cemetery fence. Ms. Varnadore based her request on the complaints received concerning the fence and the possibility there is a clear site triangle violation. Mayor Bustle questioned the value of such assessment unless funds are budgeted to address every site triangle violation in the City.

Reported she will be attending the Institute for Elected Municipal Officials training this weekend in Tampa.

Mr. Williams acknowledged Mayor Bustle's feeling on the cemetery fence, but stated there is an issue with the fence. He agreed with Ms. Varnadore that an evaluation of the issue should be made to substantiate the City's position.
