Mayor Bustle called the meeting to order at 7:02 pm, followed by a moment of silence for overseas military personnel and the Pledge of Allegiance to the United States Flag.

All persons planning to address Commission were sworn in.

PUBLIC COMMENT:

Kerry Ward of Wachovia Bank informed Commission Manatee School of the Arts will be approaching the City concerning another bond issue to fund improvements to the school - \$3.5 million in 2007 and \$3 million in 2008. He reiterated the fact the City faces no liability in this type of bond issue, and the Strand vs. Escambia County case has no impact on this type of bond financing.

Jonathan L. Davis, representing residents of 24th Ave W, presented a petition opposing the eight foot sidewalk being constructed through their neighborhood. Also speaking in opposition to the sidewalk were Pastor Greg Burgess, Jason Niles and Travis Longpre. Reasons cited for their opposition were:

- Lack of notice to directly affected property owner or residents of the area
- Potential flooding
- Potential increase of thefts
- Potential for citations because of the inability to park without vehicles extending into the sidewalk
- Impact to existing trees
- Lack of lighting

Grants Coordinator Tanya Lukowiak explained the project is part of the Trails and Greenways grant funding and the project, once finished, will connect Hydrant Park out to Snead Island, via trails. She cited the noticing the City performed to meet legal requirements. She also confirmed no private property had been taken, construction of the trail is occurring only in the City's right-of-way. After discussing the issue, Commission directed staff to schedule a meeting with residents of the area so they can understand the full origin of the project and review the plan. Mayor Bustle stated the City would try to work with the residents of the area on the issues they have brought forward.

3. PUBLIC HEARING: ORDINANCE NO. 07-946

Mayor Bustle opened the public hearing.

Bob Rickey commented on Sec. 10-106(1)(a) that would prohibit a dock and a set of davits on a seawall. Commission concurred it was intended that both uses be allowed on an individual lot provided the required setbacks were met, and instructed staff to make the minor change to the ordinance.

Mayor Bustle closed the public hearing.

MOTION: Mrs. Lancaster moved, Ms. Cornwell seconded to adopt Ordinance No. 07-

Discussion: Ms. Varnadore commented on the fact boathouses and roofed structures were not allowed in the canals and should not be allowed on the river. Mayor Bustle explained the ordinance does not affect **boathouses** in the river, as other agencies grant the permit; the City's ordinance requires a permit so the Building Department can confirm the structural integrity of docks.

Motion on the floor carried 4-1. Ms. Varnadore voted no.

10. DEPARTMENT HEADS' COMMENTS

Mr. Lukowiak

Discussed the possibility of purchasing a reverse 911 system with a block of 10,000 minutes (which will cover one incident) for approximately \$5,000. Mr. Lukowiak will research to determine if FEMA will reimburse the City in the event of a weather event.

Advised Commission he will remove the 7th Street extension project from the CIP. Mrs. Lukowiak has identified a possible funding source but, the project will not qualify if it is on the CIP. Commission did not object.

Informed Commission the City owns all the land for the Jackson Park project and Westra Construction is ready to begin the project. Manatee County's representative in the project has stated that the project must be bid if the county participates in the funding of the project. Mr.

Lukowiak stated his quotes are from 2005-2006 contracts, and he fears the cost of the project may escalate. He is negotiating with the county to use Westra's piggy-back contract so the project will not be delayed while waiting for 17th Street project to begin. Stating his desire to complete the project as soon as possible, he informed Commission City funding is available to complete the project and then the county can be billed. Mr. Lukowiak confirmed there is no written approval for the Jackson Park project from the county commission. After discussing the issue, the majority of Commission concurred with proceeding with the project.

Mr. Freeman

Mrs. Lukowiak

The sales office for Palmetto Town Center will open Tuesday.

The final draft of the school concurrency report will be on the October 1, 2007 workshop agenda. Mr. Lukowiak will advise Commission the correct date of the Council of Governments meeting.

Attorney Hall

Referring to the Strand v. Escambia case, the Supreme Court granted the motions. FLOC will have oral argument on October 9, 2007.

11. MAYOR'S REPORT

Updated Commission on what the news commentator reported on the referendum amendment.

Reported he will be in Naples Thursday through Sunday for the Chamber of Commerce retreat.

12. COMMISSIONERS' COMMENTS

Ms. Varnadore

No report.

Mr. Bustle

Staff confirmed the new cemetery mirror has been ordered, and a reconfigured step-down in the cemetery fence will cost approximately \$1,500.

Opined the telemetry meters may be advantageous and considered phasing them in. He requested the topic be brought back to a workshop.

Mrs. Lancaster

Advised Commission the problems around Groover's Market are escalating. Chief Lowe and Mayor Bustle discussed the steps the City has taken to alleviate the problem. Mayor Bustle suggested a petition of surrounding residents may draw attention to the problem. Commission briefly discussed the involuntary annexation process.

Mr. Ball

Referring to involuntary annexation, he stated he would like to see the City's border in that area as 17th Street. Attorney Hall will research the involuntary annexation statutes.

Ms. Cornwell

Suggested IT should update the City's website to include a "What's Happening" area for the residents to access.

Palmetto High School's football team is currently undefeated. She suggested that announcing the team's record on an electric sign as the season progresses would be positive recognition of their efforts.

Regarding existing sign issues, Mr. Lukowiak informed Commission McDonald's has hired a lobbyist, Riverside Plaza is waiting to hear from the property owner before turning on its sign and the City will delay a decision on the Civic Center sign in the City's right-of-way until after the meeting with the county administrator.
