Mayor Bryant called the meeting to order at 4:30 p.m.

## 1. ORDINANCE 2015-01 SOLICITATION

Attorney Rudacille explained that the reason this proposed revision to the current ordinance is being brought forward is because of a recent solicitation of people in their vehicles within the City. Commission has been provided a copy of the current code as well as a copy of the language in Manatee County's code for solicitation. The primary difference between the two is that the County does not have a licensing process for solicitors.

Chief Wells stated that there is a need to control the solicitation that occurs within the intersections of the City. There is a statute that does not allow for solicitation in major roadways; the benefit to adding this language to the code would be to allow better enforcement by the officers.

Mayor Bryant opined that having solicitors in the road is not safe for the occupants of the vehicle, nor for the solicitor approaching them.

Discussion ensued regarding the permitting process. Chief explained that currently the applicant starts at City Hall and is sent down to the Police Department for his signature. He said this really is no longer necessary because he does not run criminal backgrounds on them; he does like to know about the solicitation to give his officers that information. Ms. Foley stated that this can be changed, and she can provide Chief with a copy of the permit instead of sending the applicant down to his Department. Ms. Foley was asked to provide a "FAQ" with the permit to give the applicant understanding of the dos and don'ts of soliciting in the City. It was opined that directing them to read the ordinance may not give the applicant a clear understanding.

The consensus of Commission was to have the attorney incorporate the Manatee County language regarding solicitation prohibited in roadways into an ordinance and bring forward for a first reading.
