Commissioner Williams discussed the fish estuary project. Mr. Burton explained that the idea/purpose of creating this habitat is for the future. Mr. Williams asked Mr. Burton to research in the minutes for any discussion of fish estuary along Riverside and the Manatee River.

Mr. Burton indicated that at a September Workshop he will bring forward conceptual drawings for the property downtown and provide an update on Connor Park.

Mr. Burton explained that the CRA is lacking a "second in command". He is working on a job description for a full-time second person at the CRA so that if something were to happen, the CRA wouldn't be left without someone who could pick up the work and continue. He will bring forward the job description when complete.

Commissioner Smith expressed a sense of urgency for restrooms to be installed at MLK Park. Mr. Burton explained that a long term project is to work with the Palmetto Youth Center. In the interim, a purchase of portable restrooms can be made and installed at the Park. Mr. Burton will get with Mr. Tusing and Mr. Rayan regarding the temporary restrooms.
