2. ORDINANCE 2020-01 CITY SEAL

Attorney Barnebey informed the Commission that he has performed research on other Florida municipalities to find similar ordinances to this one. He found over 100 other ordinances with 50 on file with the Clerk's office if requested for review. He stated that the intent of this Ordinance is to protect the City of improper use of the seal and that Florida Statue 165.043 provides for the City to designate an official seal and make it a second degree misdemeanor to use the seal without express approval of the City Commission.

Commissioner Smith requested to see a copy of the other ordinances and asked Attorney Barnebey how this ordinance will be enforced. Attorney Barnebey provided the Commissioner with a copy of the other ordinances and explained that enforcement will be a warning letter and if continues, then other measures can be decided upon.

Commissioner Cornwell would like information in the Ordinance regarding the City logo being distributed by authorized employees, elected officials, etc. in the format of pins, pens, notepads, novelty items, stickers, etc.
